Thank you to all those who have helped me throughout the year. Thank you also to Scott Murray from Tester Porter who again audited our books for free. The Audited Financial Reports are tabled. Scott has also indicated that he would be prepared to do the same again next year. I would like to suggest that the P&C send him a letter of thanks.

Note: Our books do not legally need to be audited by a qualified auditor, just someone who understands what they are doing.

The **Balance Sheet** (above) shows that we currently have \$15,326.45 which is held at the South West Slopes Credit Union in a cheque account and a term deposit.

The **Profit and Loss Statement** (over the page) shows all the money we made and spent during the last year.

The Deb Ball is our biggest fundraiser. 'Other fundraising events' are detailed under the P&L. Donations to the high school are also detailed below the P&L. We supported the fencing of the school grounds for \$20,000, payments to support student who represented the school at State and National level, and donations toward the Open Day and the Year 7 Welcome evening. We also paid the first of three annual payments of \$5,500 towards materials for the building of shade structures in the school playground. We have promised payment of up to \$3,000 towards new sporting team uniforms when needed.

This will be my last Treasurer's Report as I am standing down as all my children have left YHS. Thank you especially to Sharon Staff who has offered continual support over my time as treasurer, particularly in handling the receipts and banking for the sale of the Deb Ball tickets, a huge job, and who also stepped in when I was not able to attend meetings. I have enjoyed being part of the P & C over many years, especially appreciating hearing from various Principals about what is happening in the school and the opportunity to be a part of the school's continual growth and development.
